- The cleaning of the toilets will be increased daily and we are taking measures to reduce queuing at the toilets.



# Dr José Arribas, Head. Infectious Diseases Unit, La Paz University Hospital, Spain

Dr. José R Arribas is currently the head of the Infectious Diseases Unit and Research Director of HIV and Infectious Diseases at La Paz Hospital, professor of Medicine at Autonoma University School of Medicine Madrid and Research Director of HIV and Infectious Diseases at Hospital La Paz Institute for Health Research - IdiPAZ. Dr. Arribas received his medical degree from the

Complutense University School of Medicine, Madrid. Following this, he completed his residency in Internal Medicine at La Paz Hospital before going on to pursue a fellowship in Infectious Diseases at Washington University, St. Louis, Missouri, USA. Dr. Arribas is the current president of GESIDA (Spanish Group for the study of AIDS), former chair of the antiretroviral panel of the European AIDS Clinical Society (EACS) guidelines and member of the editorial committee of Antiviral Therapy, HIV Medicine, Open Forum in Infectious Diseases and Lancet HIV.

Infectious Diseases of King's College London, and holds the role of head of virology early development with Roche Pharma Research & Early Development. # Anne Glew, HIV Prevention Coordinator, The Brunswick Centre, England

Anne Glew is the HIV Prevention Coordinator within the HIV Service at the Brunswick Centre, a small charitable organisation that works across two local authority areas in West Yorkshire made up of small urban and remote rural areas. She works with communities most at risk of HIV to inform, empower and support individuals from these communities to prevent HIV transmission, and seeks

to redress the health and social inequalities experienced by these communities. Her background is in Community development, she managed a Local Authority Community Work Team for over 25 years and puts her experience to good use in this role. Using community development models to encourage individuals to be actively involved in the identification and definition of the needs of their own communities. Anne represents the Brunswick Centre at HPE where they are a Local Activation Partner (LAP).



### Anthony Harrison-West, Sexual Health Manager, Renaissance UK

Anthony joined Renaissance UK, a substance misuse and sexual health charity in Lancashire, as a Sexual Health Outreach Worker in 2014. In 2015 he was successful in moving into the role of LGBTQ+ Community Development Lead for the HORIZON project, which is Blackpool's integrated substance misuse and non-clinical sexual health service. Dr Jones is currently dual training in Geriatric and Internal Medicine in London, United Kingdom and is a former NIHR academic clinical fellow. He currently works at both the Mortimer Market Centre and the Royal Free Hospital with his academic attachment being with the MRC Unit for Lifelong Health and Ageing at UCL. His specialist interest is ageing in people living with HIV and his research interests are focused on the impact of multimorbidity and frailty in older people living with HIV, delivery of holistic health care to this group and increasing awareness and knowledge of people living with HIV and older LGBTQ+ people amongst those working in Geriatric Medicine. Clinically he helps deliver general HIV care at Mortimer Market as well as delivering the Sage clinic at the Royal Free Hospital which is specifically aimed at older people.



# Dr Harriet Kemp, NIHR Clinical Lecturer, Imperial College Healthcare NHS Trust, UK

Dr Kemp is an NIHR Clinical Lecturer with APMIC & the Pain Research Group. Clinically she works as an anaesthetic registrar in the Imperial School of Anaesthesia. Having completed an NIHR Academic Clinical Fellowship in Anaesthetics, Dr Kemp was appointed to the NeuroPain Grant to investigate pain in patients with HIV. She completed her doctoral thesis on chronic pain

in HIV infection in 2019. Her areas of interest include quantitative sensory testing, conditioned pain modulation, and other deep phenotyping measures in neuropathic pain. She was also the joint project lead for the Pain in INTensive Care (PAINT) Study with Dr Helen Laycock and the Pan London Perioperative Audit and Research Network and continues to work on studies investigating acute and chronic pain in the critically ill. She is also currently working on the NIPPR study (funded by the British Pain Society Clulow Award) investigating neuropathic pain in HTLV-1 infection with the National Centre for Human Retrovirology.



# Professor Sebastian Lucas, Emeritus professor of pathology, Guy's & St Thomas' NHS Foundation Trust, UK

Professor Lucas has been studying HIV disease – both in biopsy and morbid anatomy – for more than 40 years. And has practiced pathology for 48 years. In that time, he has witnessed, and contributed somewhat to, the changing patterns of death management, investigation and

certification. As HIV disease changes with improvements in clinical treatment and infected people live longer, it is ever more important that we categorize their deaths optimally. The current minimal – and the ideal – requirements of death certification in the UK will be discussed.



# Dr Swapna Mandal, Consultant Respiratory Physician, Royal Free London NHS Foundation Trust, UK

Dr Mandal is the lead Consultant Physician in Sleep and Ventilation at the Royal Free London NHS Foundation Trust, focusing on the management of sleep disordered breathing, the service covers a large geographical area treating range of patients with often complex needs including

those with progressive neurological disorders and ventilatory failure. Additionally, she has set up a joint respiratory and palliative advanced respiratory care clinic for patients with chronic respiratory conditions requiring input from both specialties. She is also the clinical lead for lung function services across the trust and has introduced innovative diagnostic pathways. She continues her pursuit of academic interests in sleep and ventilation medicine and is supervising several PhD students as well as actively improving patient care through quality improvement projects. She won a BMJ award for an innovative outpatient pathway and was a regional finalist for the Peter-Carr Award. More recently she has led the post-acute COVID service at the Royal Free Hospital and has also published in this area.



# Fiona Marra, Lead Pharmacist HIV/HCV FRPharmS (Consultant), NHS Greater Glasgow and Clyde, and University of Liverpool, UK

Fiona Marra works clinically in Glasgow where she is Lead Clinician for Paediatric Infection and Immunology Network for Scotland, and senior clinical pharmacist for adult HIV/HCV. She is also Principal Pharmacist and part of the Editorial Board of the University of Liverpool, Drug Interactions

websites, where she writes the content. Fiona is completing a PhD in Clinical Pharmacology of HCV and has completed diplomas in International development and travel medicine and MSc in Advanced Pharmacy. She sits on the Committees of the British HIV Association (BHIVA) Hepatitis Group, the Scottish Malaria Group and is part of the Editorial board of Scottish paediatric Infection and Immunology network (SPAIIN). She is an author of the EASL Recommendations for HCV 2018 and 2020 and lectures globally on HIV and HCV drug interactions. She has published substantially in this field.

# Dr Louise Melvin, Consultant in Sexual & Reproductive Health, Sandyford Sexual Health Service, UK

Louise Melvin is a Consultant in Sexual & Reproductive Health (SRH) based in Glasgow at Sandyford Sexual Health Service. Louise first qualified as a pharmacist, switching soon after to medical training. After specialty training in the east of Scotland in general Obstetrics &

Gynaecology, followed by subspecialty training in SRH, Louise moved back to the west in 2008, taking up a consultant post at Sandyford. She was the Director of the Faculty of SRH (FSRH) Clinical Effectiveness Unit until 2014. Having acquired a cohort of transgender patients with SRH issues, Louise was invited to join the NHS Greater Glasgow & Clyde gender service which is hosted by Sandyford. The service takes referrals from all children and adolescents under 18 years in Scotland, and adults from six of the Scottish health boards. There is no formal training programme for transgender healthcare. Gender incongruence is now classed as a condition related to sexual health, although psychological comorbidity is common. Therefore, the multidisciplinary team members in the Glasgow gender service in addition to her SRH work.



# Ms Fungai Murau, Independent Consultant, UK

Fungai Murau is a researcher in the HIV field with special interest in mental health (quality of life for people living with HIV), migration and educating adolescent girls in making informed choices about their sexuality and wellbeing.Fungai studied at the renowned Institute of Development studies with her MA (poverty and development) dissertation focusing on the mental health of

undocumented women living with HIV in the UK. Fungai currently works as an independent consultant focusing on policy, advocacy and project delivery. Fungai is affiliated with national and international advisory boards. These include, board member at Beyond Stigma, SWIFT (Supporting Women with HIV Information Network), and a member of the Organising Committee of the annual International Women and HIV Workshop.



# Hajra Okhai, Research Statistician, University College London, UK

Hajra is a Research Statistician based at the Institute for Global Health, University College London since 2018. She has collaborated on designing, analysing and publishing a range of research projects exploring clinical and psychological outcomes using large, representative datasets of people living with HIV in the UK including the UK Collaborate HIV Cohort (CHIC),

Positive tRansItions through Menopause (PRIME) and Pharmacokinetic and clinical Observations in PeoPle over fifty (POPPY) studies. Currently, Hajra is collaborating with SWIFT (Supporting Women with HIV Information Network) to understand the knowledge of health care providers and the barriers and facilitators they face in relation to the diagnosis and treatment of low bone mineral density (BMD) amongst women living with HIV.





# Professor Chloe Orkin, Professor of HIV Medicine, Queen Mary University of London, UK

Chloe Orkin is Professor of HIV Medicine at Queen Mary University of London and Consultant Physician at Barts Health NHS Trust where she leads on clinical trials in HIV. She is the Academic Lead for Equality Diversity and Inclusion for her medical school and Director for the SHARE

research centre for health equity. Chloe is immediate past Chair of the British HIV Association, President of the Medical Women's Federation and a member of the governing council for the International AIDS Society. Her specialist interests are anti-retroviral therapy and health equity.



# Dr Roger Paredes, Head, infectious Diseases Department, Hospital Germans Trias I Pujol, Catalonia, Spain

Roger Paredes, MD, PhD, is the Head of the Infectious Diseases Department, Germans Trias i Pujol Hospital and Head of the Microbial genomics Group @ irsiCaixa, both in Badalona, Catalonia, Spain. He obtained a PhD in Medicine and Surgery from the Autonomous University of Barcelona

(UAB) and specialised in HIV resistance, at Brigham & Women's Hospital in Boston and Harvard Medical School, thanks to a post-doctoral scholarship from "la Caixa". He has demonstrated the clinical utility of new methods of sequencing HIV in both high- and low-income countries. He is a member of the WHO HIV Drug Resistance Strategy (ResNet) Steering Committee and of the International Antiviral Society-USA, which publishes an international annual update of drug resistance mutations in HIV-1. His group has led pioneering research into the role of the gut microbiome in the pathogenesis of HIV infection and chronic inflammation. He is Coordinating of the Horizon 2020 10M-euro MISTRAL Project to decipher the role of the microbiome on HIV pathogenesis and cure (www.mistral-hiv.eu)



# Dr Dimitra Peppa, Associate Professor in HIV Immunology/Honorary Consultant in HIV Medicine, University College London, UK

Dimitra Peppa is an Associate Professor in HIV Immunology and Honorary HIV Consultant at the Institute of Immunity and Transplantation (IIT), UCL. She runs an immunology research lab studying

immunity in human disease including chronic viral infections with HIV, HBV and emerging viral infections (SARS-CoV-2). Her lab has expertise in adaptive immunity and NK cell biology with a focus on translational research and the identification of new targets for 'cure' strategies and vaccine development. Other projects focus on dissecting the network of drivers of chronic inflammation associated with premature ageing and multi-morbidity in people living with HIV.

Jürgen Rockstroh, MD, is Professor of Medicine and Head of Infectious Diseases at the University Hospital of Bonn in Germany. He earned a Doctor of Medicine degree from the Rheinische Friedrich-Wilhelms University of Bonn, and completed his residency in the Department of

Medicine also at the University of Bonn. In addition to his clinical practice, Dr Rockstroh is involved in HIV research on: antiretroviral therapy, including new drug classes; the course of HIV disease in haemophiliacs; and HIV and hepatitis co-infection. More recently, he has also started working on the impact of COVID-19 on HIV-coinfection. He has been an investigator in multiple clinical trials of antiretroviral agents and treatments for HIV, hepatitis co-infection and COVID-19. From 2007-2011 he was elected as the president of the German AIDS Society. He is also since 2009 a member of the executive committee of the European AIDS Clinical Society (EACS) and from 2011-2020 member of the governing council of the International AIDS Society. He also was the chair of the National German AIDS Advisory Panel from 2011-2017 and the EACS coinfection guidelines from 2008-2017. In 2015 Professor Rockstroh was elected chair of HIV in Europe (in 2019 renamed as EuroTEST) and from 2019-2020 president for EACS. The German Society for Infectious Diseases awarded Dr Rockstroh and his co-authors the prize in clinical infectious diseases in 2002, and the national AIDS research prize in 2005. Dr Rockstroh has authored or co-authored over 700 publications in peer-reviewed journals, and over 100 book chapters.



# Professor Caroline Sabin, Professor of Medical Statistics and Epidemiology, University College London, UK

Caroline Sabin is Professor of Medical Statistics and Epidemiology at University College London (UCL) and is the Director of the NIHR Health Protection Research Unit in Blood-Borne and Sexually Transmitted Infections at UCL. She is also the current vice-chair of the British HIV

Association (BHIVA). Caroline's interests are in describing the natural history of HIV infection, identifying prognostic markers and describing responses and adverse events to cART. She established the UK Collaborative HIV Cohort (UK CHIC) Study, was the principal statistician and co-lead for the D:A:D Study and is the co-principal investigator for the POPPY study, a large cohort set up to investigate the associations of ageing and HIV in the UK and Ireland. Since the start of 2020, she has been one of the two Editors-in-Chief of HIV Medicine, BHIVA's flagship journal.

Maya is a specialist registrar, currently training in infectious diseases and microbiology in Manchester. She studied her Diploma in Tropical Medicine and Hygiene (DTM&H) at the Liverpool School of Tropical Medicine (LSTM) in 2015. Subsequently she worked for the


