Thank you for your assistance. I hope that the information below will be helpful for Dr De Ruiter.

As I detailed, I work in the implementation team at NICE. My specialist area is maternity and child health, and I am not at all an expert in areas related to HIV.

I do not work on the team that develops the guidelines, my role is to support the implementation of guidance into practice. This can involve producing resources for organisations or practitioners, or working with organisations such as BHIVA to explore implementation issues and opportunities.

I have read the comments that were submitted during the pre-publication check, but would welcome the opportunity to discuss how you feel about the NICE guideline, and how it relates to practice.

It would also be useful to discuss anything that we could do to clarify any issues.

I can feed back any issues relating to the actual recommendations, but it is outside of my role to make any changes to them.
