







 - Individual and community focus, high quality, holistic, long term, supportive, trustworthy, safe, reliable.

NHS Outcomes Framework 2012


Preventing people from dying prematurely


Enhancing quality of life for people with long term conditions

Diagnostic testing for HIV

Access to and retention in HIV treatment and care

Provision of outpatient treatment and care for HIV and co - morbidities

Safe prescribing and effective management of medicines

Appropriate in patient care for HIV related problems

Promotion of $\,$ mental , emotional and cognitive wellbeing as it relates to HIV $\,$

Promotion of good sexual health

Maximise opportunities for appropriate self management
