

There are also good links to the city centre from both Heathrow and Gatwick airports. Journeys by either Heathrow or Gatwick Express take about 1 hour.



Speaker Biographies



Sanjay Bhagani is a Consultant Physician in Infectious Diseases and HIV Medicine at the Royal Free Hospital, London and Honorary Senior Lecturer in Infectious Diseases at University College London. After completing his postgraduate training in Infectious Diseases and Internal Medicine in London, he joined the Royal Free Hospital as a Consultant Physician where he established and is the current lead of a multi-disciplinary HIV/hepatitis co-infection service. This is a tertiary referral service at the fore-front of service delivery in all aspects of HIV/viral hepatitis co-infection, ranging from access to phase 2/3 clinical trials for new agents to joint liver transplant assessment and post-transplant care. His team's research interests include epidemiological, virological and clinical aspects of acute HCV amongst HIV-positive MSM, use of non-invasive tests for liver assessment in resource-rich and resource-limited settings, implementation and clinical research in the management of viral hepatitis and HIV co-infection in resource-limited settings, and phase 2/3 clinical trials for new agents for treating HCV and HBV. Sanjay is the current chair of the British HIV Association's Viral Hepatitis Group and serves on the HIV/hepatitis guidelines committee for both the British HIV Association and the European AIDS Clinical Society. He serves on the editorial boards of AIDS Research and Therapy and BMC Hepatology, Medicine and Policy and is a trustee at AIDSOrphan. Sanjay has a passion for teaching and is currently on the steering committee for the EACS Advanced HIV course and a member of the board of examiners for the Diploma in HIV Medicine, UK.

Christoph Boesecke completed his medical studies at Charité University in Berlin and received his Doctorate in Medicine from the University of Hamburg for his research in acute HIV infection. He held a 2-year postgraduate position studying integrase inhibitors in acute and chronic HIV infection at the National Centre in HIV Epidemiology and Clinical Research (now The Kirby Institute) in Sydney, Australia. Christoph is currently working as an Infectious Diseases Specialist and Clinical Research Fellow at the University of Bonn. His main areas of research are focused on co-morbidities and co-infections in HIV, particularly acute hepatitis C.

Gary Brook is Clinical Lead for HIV/GUM at Central Middlesex, Northwick Park and Ealing Hospitals, London and also maintains an interest in infectious and tropical diseases. He first became involved in viral hepatitis in the late 1980s when he wrote his MD thesis on interferon treatment for chronic hepatitis B at the Royal Free and St Mary's Hospitals London. Subsequently, as well as continuing with a research interest in hepatitis, Gary has been the lead for national and international viral hepatitis management guidelines on behalf of BHIVA, BASHH and IUSTI/WHO.

Ashley Brown is a Consultant Hepatologist at St Mary's Hospital and Adjunct Reader at Imperial College London. He studied as an undergraduate at the University of Liverpool before undertaking specialist training in liver disease, and obtaining an MD from the University of Newcastle-upon-Tyne. Ashley has a major clinical interest in viral hepatitis with a special interest in accessing care for difficult-to-reach populations. His research interest lies in novel treatments for HBV and HCV, and he serves as Chief or Principal Investigator on a large number of clinical trials. Ashley is currently Chairman of the London Joint Working Group on HCV in PWIDs, and former Chair of the British Viral Hepatitis Group. He has published numerous articles and abstracts in peer review journals and is a frequent speaker at national and international liver meetings.

Janet Catt is an Independent Non-medical Prescriber, and has had a varied nursing experience that has included oncology, haematology, palliative care and health visiting. Since 2008 she has been a Lead Nurse Specialist Practice at the Royal Free Hospital, London where she manages a team of clinical nurse specialists and leads on the development of the nursing service. As part of her role, she also researches local epidemiology in order to develop ways to improve patient pathways. Janet is a founder member of the steering group for the Interactive Summit on Hepatitis and sits on the London Joint Working Group for Substance Misuse and Hepatitis C. She is a regular speaker at international conferences.

Harry Dalton is a Consultant Gastroenterologist at the Royal Cornwall Hospital and Honorary Senior Lecturer at the European Centre for the Environment and Human Health, University of Exeter, Truro. Over the last 10 years he has been working on HEV. Harry has published many papers on this subject in diverse journals, including *New England Journal of Medicine*, *Lancet, Lancet Infectious Diseases*, and *Annals of Internal Medicine*. He contributed to the WHO-sponsored Global Burden of Disease project as an expert panel member on HEV. In 2011, he was awarded the Dame Sheila Sherlock Travelling Fellowship to develop collaborative links with the HEV research group in Europe.

Sergii Filippovych is Director: Treatment, Procurement and Supply Management of ICF 'International HIV/AIDS Alliance in Ukraine'. His experience in healthcare spans more than 35 years, and he has 20 years' experience in the field of HIV/AIDS treatment and prevention. He has witnessed and significantly contributed to the origin and development of treatment programs for key populations in Ukraine. Programs include but are not limited to ART, OST, STI and hepatitis treatment. Sergii headed the implementation of hepatitis C treatment services delivery to 100 HIV-positive clients of OST and now provides leadership of the project 'Scaling up accessible and effective HCV treatment with DAA through a community-engaged treatment model for the most vulnerable populations in Ukraine'.

Graham Foster is Professor of Hepatology at Queen Mary's, University of London and a Consultant at Barts Health in East London. He trained in Medicine at Oxford and London Universities in the 1980s and completed a PhD in Molecular Biology in 1992. Graham has a long-standing interest in the management of chronic viral hepatitis and runs a clinical research program studying the natural history of viral hepatitis, its impact upon patients and their communities, and novel therapies for this disease. He leads a national study investigating community screening for viral hepatitis and supervises a laboratory research program investigating novel replication models for hepatitis C. He is the editor of the Journal of Viral Hepatitis and has published widely in the field of viral liver disease. He is a past President of BASL, Vice Chairman the UK Department of Health Advisory Group on Hepatitis, and a member of a number of patient advocacy groups.

Ricky Gellissen has been in HIV nursing for over 20 years in a variety of settings. In 2008 he started a newly created role as HIV & Hepatitis Co-infection Clinical Nurse Practitioner. This year he transferred to Hepatology as a Hepatitis CNS, still providing diagnosis and treatment services to patients with HIV and hepatitis co-infection. He continually seeks to promote skill and knowledge transference between HIV and hepatology services. Ricky is an Executive Committee Member of the National HIV Nurses Association (NHIVNA) and on the NHIVNA Blood-Borne Virus Working Group, which is a collaboration between NHIVNA and the British Association of the Study of the Liver Nurse Forum (BASLNF). He is also a committee member of Pan London Nurse Education and Training (PLaNET), a Pharma sponsored series of evening educational events for HIV nurses in London.

Lynda Greenslade is a liver nurse with long-standing experience in caring for patients and their families affected by liver disease. After becoming 'hooked' on hepatology as a student nurse while working on the Liver Unit at the Royal Free Hospital, London, she returned to the specialty following spells in orthopaedics and intensive care. Since then, Lynda has worked as a liver ward sister and a research nurse, working mainly in portal hypertension. In Her current role is as a Clinical Nurse Specialist in Hepatology, she mainly looks after patients with the complications of liver disease, stable cirrhosis, or newly diagnosed with liver disease and haemochromatosis. Raising awareness of liver disease both within the profession and to the wider public is also part of her role. Lynda is currently working on a project with the Marie Curie Palliative Care UCL team, looking at ways to improve end-of-life care for patients with end-stage liver disease. She is a committee member of both the British Association of the Study of the Liver Nurse Forum and the RCN Gastroenterology Forum, and enjoys teaching in the clinical area and supporting nurses new to hepatology.

Matthew Grundy-Bowers has worked in the field since 1994, and is currently the Consultant Nurse for HIV/Sexual Health at Imperial College Healthcare NHS Trust and Honorary Senior Lecturer at City University London. He completed his PhD in Public Health in 2014 having been awarded an NIHR clinical fellowship. Matthew is passionate about developing others and regularly teaches both nurses and doctors including on the Faculty of Sexual & Reproductive Health Diploma and the British Association for Sexual Health & HIV STIF competencies. He is actively involved in professional organisations and is an executive member of NHIVNA and the BASHH STIF steering committee.

Philippe Halfon is Professor of Medicine at Paris Medical College. He received his PharmD degree in 1985 from the University of Marseilles and completed training in Virology in Saint Louis Hospital and the Pasteur Institute in Paris. He received his PhD degree in 1993 and post-doctoral training in Virology at McGill University, Montreal. He received is MD degree from the University of Marseilles and completed training in Infectious Diseases. He has published over 250 peer-reviewed papers and three books, and holds four US patents. Philippe is the founder of several biotechnology companies focusing on antiviral drug discovery and development, and is currently developing one drug in HCV and two innovative drugs in the treatment of cancer stem cells. Philippe has received the Tremplin Award and is a member of the French Agency against AIDS.

Speaker Biographies



Magdalena Harris is a qualitative sociologist based at the London School of Hygiene and Tropical Medicine. She conducts a programme of research, using life history and other qualitative methods, investigating the lived experience of hepatitis C, its treatment and prevention in the UK. She has published widely on hepatitis C and issues impacting people who inject drugs; providing 'expert' guidance on hepatitis C and harm reduction for institutions such as NICE and EMCDDA. Magdalena is a collaborative partner in the European Hepatitis C and Drug Use Initiative and a board member for the Hepatitis C Trust, the *International Journal of Drug Policy*, the *Journal of Hepatitis Medicine & Policy*, and the Global Congress for Qualitative Health Research.

Andrew Hill is a Senior Visiting Research Fellow at Liverpool University, specialising in treatment access issues in HIV and Hepatitis. He graduated from Oxford University, with a PhD from the University of Amsterdam. He has published several papers on the true cost of production of drugs for HIV, hepatitis B and hepatitis C.

Patrick Ingiliz is a Specialist in Internal Medicine and Infectiology. He is currently working as a consultant in the Center for Infectiology in Berlin. His main fields of interest are HIV infection and viral hepatitis coinfection. His clinical research projects are focused on acute hepatitis C infection, liver fibrosis progression and steatohepatitis in HIV infection. Patrick is actively involved in numerous trials on direct-acting agents against hepatitis C in mono- and in coinfected subjects, and he plays an active role in several national and international research collaborations.

Svilen Konov Svilen Konov started working in the fields of HIV in 2000 and HCV in 2005. He has a degree from the London School of Hygiene and Tropical Medicine. Svilen worked at HIV i-Base as a treatment information and advice officer until 2010 and has experience in working on international projects with the European AIDS Treatment Group where he was the HCV coordinator. He has been involved in more than 100 training events both in Western, as well as Eastern Europe and Central Asia. Currently he is a director of SEVT Ltd, a company that provides consultancy services in medical and general research methodology, medical and general literature translation, editing and writing, and patient organisations and communities' relationship and development. Svilen speaks Russian, Bulgarian, Japanese, and German. His current interests are in mathematical modelling, clinical trials' design and pharmacogenomics.

Vincent Mallet is Senior Physician and Professor in the Department of Hepatology at Cochin University Hospital in Paris. He is Research Director at the Pasteur Institute in Paris and has founded a company on big-data and health care. Vincent has worked on basic and clinical aspects of liver diseases since 1999. His main interests are HBV, HCV and HEV infections in compromised hosts and the development of novel immunomodulatory therapies for hepatocellular carcinoma.

Natasha K Martin is an Associate Professor in the Division of Global Public Health in the Department of Medicine at the University of California San Diego. She is also an Honorary Senior Lecturer at the University of Bristol. Natasha is an infectious disease and economic modeller with over 15 years of experience modelling biological systems. She earned her doctoral degree in mathematical biology from the University of Oxford, and undergraduate degree in mathematics and biology from Stanford University. Following her doctorate, she worked as a postdoctoral fellow at the University of Bristol and London School of Hygiene and Tropical Medicine. Natasha's work focuses on using dynamic epidemic modelling to evaluate the impact and cost-effectiveness of HIV, HCV and HBV prevention interventions among high-risk populations such as people who inject drugs, men who have sex with men, and incarcerated populations. She is one of the leading researchers examining the potential impact and cost-effectiveness of HCV treatment as prevention. Currently she is engaged in a number of HIV and HCV intervention evaluation trials in international settings such as Mozambique, India, Kenya, Ukraine, Mexico, Australia and the UK.

Mojca Maticic is a specialist in internal medicine and infectious diseases, with postdoctoral training at the Middlesex Hospital and Royal Free Hospital, London. She is the Head of the Viral Hepatitis Unit at the Clinic for Infectious Diseases and Febrile Illnesses, University Medical Centre, Ljubljana, and Professor of the Medical Faculty, University of Ljubljana. Mojca leads the interdisciplinary National Viral Hepatitis Expert Group in Slovenia and is a member of the HIV/AIDS Committee at the Slovene Ministry of Health. She co-authored national consensus guidelines for the management of hepatitis B and hepatitis C in Slovenia and co-organised a national healthcare network for the management of hepatitis C in people who use drugs.



Stefan Mauss specialised in internal medicine and gastroenterology at the Heinrich-Heine University in Düsseldorf. After leaving the university in 1996 he opened, as a founding member, the Center for HIV and Hepatogastroenterology, an outpatient clinic and privately based research centre. His primary research interests are complications of antiviral therapy and their management in HIV, hepatitis B and hepatitis C. In addition he focuses on treatment strategies of viral hepatitis B or C in mono- or HIV-coinfected patients. Stefan has published more than 140 original articles and reviews in international journals. He has edited numerous books on HIV and viral hepatitis including 'Hepatology – a clinical textbook', which is regularly updated and available free at www.hepatologytextbook.com.

Mark Nelson is a Consultant Physician at the Chelsea and Westminster Hospital, London. He trained at Jesus College, Cambridge and Westminster Hospital Medical School from where he qualified in 1986. He was appointed Consultant Physician at this hospital in 1991 where is presently the Lead for HIV in patient and day case care and is the Professor of HIV medicine at Imperial College Medical School, where he is also the Deputy Senior Tutor. He has built a large HIV practice with a special interest in HIV in patient care, co-infection with hepatitis B and C, and the clinical utility of new antiretroviral agents. He has published over 500 papers on HIV and hepatitis.

Karin Neukam is currently Research Scientist at the Valme University Hospital in Seville. She trained in pharmacy at the University of Würzburg and completed a PhD at the University of Düsseldorf, as well as a Sara Borrell postdoctoral fellowship at the Valme University Hospital, the Royal Free London NHS Foundation Trust and the University of Liverpool. Her clinical research projects are focused on real-life efficacy and safety of therapy against hepatitis C infection, hepatic security of antiretroviral therapy and liver fibrosis. Karin is the coordinator of the Spanish GEHEP and HEPAVIR multicentre collaborative national cohorts for treatment against chronic hepatitis C in patients with or without HIV infection.

Emma Page currently works as a Locum Consultant in Virology and Sexual Health at Leeds Teaching Hospitals Trust, where she has been in post for two years. She undertook her specialist training at Chelsea and Westminster Hospital London during which time she completed an MD(res) at Imperial College on the immunology of HIV and hepatitis C. Her main clinical and research interest remains HIV and hepatitis co-infection.

Jean-Michel Pawlotsky is Professor of Medicine at the University of Paris-Est. He is the Director of the National Reference Center for Viral Hepatitis B, C and Delta and of the Department of Virology at the Henri Mondor University Hospital in Créteil, France, and Director of the Academic Department 'Viruses, Immunity and Cancers' (INSERM U955). Jean-Michel has been the Secretary General of EASL (2005–2009), and an Associate Editor of Hepatology (2001–2006). He is currently an Associate Editor of Gastroenterology. He has published over 450 articles and book chapters in his areas of expertise and given over 500 invited lectures at international meetings.

Carlo-Federico Perno is Professor of Virology at the University of Rome 'Tor Vergata', and Director of the Unit of Molecular Virology at the Tor Vergata University Hospital, Rome. He also works as Consultant of Clinical Virology at the Spallanzani Hospital for Infectious Diseases, Rome. He gained his MD from the University of Rome in 1980, and graduated in oncology in 1983. From 1986 to 1989 he worked as Research Fellow at the National Cancer Institute, Bethesda, Maryland, where he collaborated in the discovery and clinical application of the first antiviral drugs used in the therapy of HIV infection, including AZT, ddC, d4T and ddl. Carlo-Federico has published more than 470 international scientific articles mostly concerning antiviral therapy. In 2001 the European Community awarded him the Descartes Award for excellence in the antiviral field. He has major expertise in antiviral therapy, clinical interpretation and therapeutic application of antiviral resistance testing. Carlo-Federico leads a group of internationally recognised researchers funded by numerous grants from Italian institutions, the European Community, and private institutions.



David James Pinato is an NIHR Academic Clinical Lecturer in Medical Oncology at Imperial College London. Since graduating in Medicine at the University of Piemonte Orientale (Italy), he has devoted his research efforts to studying the role of inflammation as a molecular mechanism underlying the progression of Hepatocellular Carcinoma (HCC). His studies, supported by international collaborations, eventually led to the qualification of novel prognostic and predictive biomarkers in HCC. David completed his research training being awarded a Masters of Research in Translational Medicine and a PhD in Experimental Medicine. He has developed considerable experience in translational oncology within the specific setting of early-phase clinical trials. He has trained in Medical Oncology as part of the Royal Marsden Hospital rotation, having migrated to Imperial College in April 2015 to take up his Clinical Lectureship. He was awarded the European School of Oncology fellowship in 2008 and the Fulbright Visiting Research Scholar Fellowship in 2010. He is supported by grants from the Academy of Medical Sciences and Action Against Cancer, and lectures internationally in the field of molecular oncology with a specific interest in drug resistance in HCC.

Lionel Piroth has been involved in clinical care and research in HIV and hepatitis viruses in France since the mid-1990s. He is Professor of Infectious Diseases at the University of Burgundy and Physician at the Hospital of Dijon, and also actively participates in trials of antiretrovirals and other anti-infective agents. Lionel has co-authored the French Recommendations on the Management of Hepatitis Co-infection in People Living with HIV for eight years.

Massimo Puoti is a Specialist in Gastroenterology and in Infectious Disease. From November 2010 he has been the Director of the Infectious Diseases Department of the AO Ospedale Niguarda Cà Granda, the largest hospital in Milan. Massimo's main fields of research are hepatitis viruses and HIV infections.

Antonio Rivero-Juarez qualified in Veterinary Science, and has worked in the Laboratory of Infectious Diseases at the Instituto Maimonides de Investigación Biomédica de Córdoba (IMIBIC) since 2010, in the field of HIV and hepatotropic virus co-infection (hepatitis C and hepatitis E). He gained his PhD in 2013, and was awarded with the Extraordinary Award of the University of Córdoba (Spain) for contributions to the field of HIV/HCV co-infection. Antonio has published more than 50 papers in the last 5 years, and is an External Investigator Assistant in the FDA (USA) and Saint Louis Hospital (France).

David Stuart is the Substance Use Lead at 56 Dean Street, addressing sexualised drug use by gay men (the practice commonly referred to as 'ChemSex'). He has been involved in the development of London's pioneering services Antidote, Club Drug Clinic and CODE clinic, and has been instrumental in placing ChemSex issues firmly on international Public Health agendas. David is also the curator of the Dean Street Wellbeing programme, a series of community engagement events designed to mobilise and engage populations in action and dialogue on topical and challenging social issues that impact sexual health and wellbeing.

Emma Thomson is a Clinical Senior Lecturer and Consultant in Infectious Diseases at the Queen Elizabeth University Hospital in Glasgow and St Mary's Hospital, Imperial College London. She is responsible for the HIV/HCV co-infection treatment service in Glasgow and runs a research lab at the MRC University of Glasgow Centre for Virus Research that focuses on understanding immunity to hepatitis C. Emma is funded by a clinical fellowship from the Wellcome Trust and as a co-investigator on the MRC STOP HCV consortium.

Emmanuel Tsochatzis is a Senior Clinical Lecturer and Consultant Hepatologist at the UCL Institute for Liver and Digestive Health, Royal Free Hospital, London. His main research interests include NAFLD, cirrhosis and portal hypertension, non-invasive assessment of liver fibrosis and loco-regional treatments for HCC. Emmanuel is the author of more than 100 papers in peer-reviewed journals. He was awarded the Rising Star in Gastroenterology Award by UEG in 2014.



Andrew Ustianowski is a Consultant Physician in Infectious Diseases at the North Western Regional Infection Unit, North Manchester General Hospital, which is one of the largest treatment centres for HCV in the UK (and one of the largest for HIV and HBV). He is Chair of the British Viral Hepatitis Group, has been part of guideline writing committees for BHIVA and other bodies, lectures widely on hepatitis, HIV and related topics, and is part of several national and international educational steering groups. He has been a member of the NHS England Clinical Reference Group for Infectious Diseases and for HCV. Andrew graduated from Guy's Hospital, London, and subsequently trained in infectious diseases, tropical medicine, HIV and general medicine in the London region.

Fabien Zoulim obtained his MD in Gastroenterology and Hepatology from Lyon Medical School in 1991. He also has a PhD in molecular and cellular biology and was trained as a post-doctoral researcher at Fox Chase Cancer Center in Philadelphia. He has been a Professor of Medicine at Lyon I University since 1997. Fabien is currently the Medical Director of the Hepatology Department at the Hospices Civils de Lyon, and Scientific Director of the Department of Immunology and Virology at INSERM Unit 1052 where he is leading the team on antiviral therapy of viral hepatitis. He has served as an Associate Editor for the *Journal of Hepatology* and is currently Associate Editor for *Gut*. He also served as an expert in the microbiology study section of the INSERM and ANRS, and in different national and international committees. He has also been a governing board member of the European Association for the Study of the Liver (EASL). He is coordinating the national HBV cure program at ANRS. Fabien received the William Prusoff award of the International Society for Antiviral Research in recognition of his work in the field of HBV molecular biology and anti-HBV therapy. Furthermore, he has been the scientific coordinator of a European community-funded network of excellence on the management of antiviral drug resistance, and is currently involved in several European projects. He has published more than 350 articles (*H*-index 59, Web of Science).
